#### Mid-Winter Board meeting

The meeting was held at Christ GMC in Jacobus, Pennsylvania. Directors in attendance were Tom Shelley, Judy Martin, Bonnie Flaharty, Dean Gladfelter, Stephen Gladfelter, Larry Gladfelter Jr., Harry Gladfelter, John Shelley, Philip Glatfelter, Rick Gladfelter and Ben Miller. Board Members who joined by conference call were Pamela Tuscany, Bonnie Baim, Rick Hoover and Chris Glatfelter. Jean Robinson and Sarah Melcher were absent.

President Tom Shelley opened the meeting at 10:02 a.m. in prayer.

Among the correspondence was a Christmas card to Judy from Henry and Myrtha Glattfelder.

From the Contact Us form on the website, Larry shared the following:

- On September 26, Joan Welch Mason inquired about Solomon, Eva and Elizabeth Turner Clodfelter. Joan is a descendant of Solomon from Missouri. Larry responded with several links of information, including: https://www.dar.org/national-society/americanspirit magazine-0. Joan replied and thanked Larry, adding that she found three facts that she didn't have previously. "Sure appreciate your speedy, knowledgeable email," she replied.
- On October 31, a message from stephencashman1@gmail.com said, "Hello! We just moved into the property directly next to the Pavilion, just thought I would reach out and say hi. I also own the 10 acres on the creek bottom with the old stone foundation. Would be great to connect with someone from your organization." Tom got in touch with Stephen.
- On November 1, we received the following message from Chip Zelch: "Our Sons of the

American Revolution chapter is rehabbing the Old German Lutheran Cemetery in Somerset Township. Big ceremony. Grave rededication. Please join us! Contact me!" Tom responded: "If anyone has an email address for Tom Clodfelter of Brookfield, Ill., he would certainly want to know about this. To the best of my knowledge, he is the only descendant of Michael who has attended Reunions."

● On January 2, we received a message from emgpsy@hotmail.com. "Long story, but in essence I am in possession of these signs (train -- 16" x 70"; PO -- 16" x 50") and wish to put them in the care of the Association for reunions. They have been passed down through our family, starting with Dr. Millard Gladfelter." Eric Gladfelter.

Treasurer Bonnie Flaharty reported that the Association had a small profit this past year. She also shared her new address: Stonecroft Apt 2106, PO Box 220, Honey Brook, PA 19344. The Financial Report was adopted and passed unanimously.

Rick reported for the Investment Committee that we took out \$2,000 for operations this past year. The investments have done well in the current market. He is still working to get to \$100,000 in investments to support operations.

The Executive Committee prepared the 2024 budget or spending plan. Using last year's financial report as a worksheet, the expenditures came out to \$13,800, with such figures as \$3,000 for Reunion costs, \$1,650 for insurance, \$2,200 for taxes and \$1,500 for maintenance and mowing.

Phil had no new information for the Brick Patio Committee, adding that he was catching up on updated statistics. For the Communications Committee, Larry reported that the Newsletter notification was emailed to 530 recipients. A second one was sent when a link went to the 2022 version of the Newsletter. There were 505 total opens. The list of subscribers now numbers 536.

Larry said he received a number of compliments on the quality of the newsletter. Sincere thanks were given to Phil, the Newsletter editor.

A subset of this committee is the Website Development Committee, which consists of board members Pamela, Harry and Larry. In addition, Holly Burns, Nic Roth and Cathy Clodfelter will be working with us.

Phil, reporting for the Historical Committee, said that he was at York County Heritage Trust the past week. Three filing cabinets will be moved, probably in April, and the new facility – now called the York County History Center -- will open in July.

Phil invited the Board members to a construction tour, which he and Rick took in February. The new facility will definitely provide an interesting look at York County.

Phil shared news about speeches that Dr. Charles presented. A woman, who has already published articles on two of Dr. Charles' talks, would like to publish his speeches relating to York County. Also among the speeches are ones presented to the Association. See excerpts of several of them later in the Newsletter. Phil showed what he thinks is the first one given by his father at the Reunion on August 11, 1945, when he was 21 years old.

Phil is hoping to organize the speeches and perhaps have them as part of this year's Reunion, when we will remember our longtime historian.

Phil is also hoping to put together a trip to various sites important to Dr. Charles. More on the Reunion weekend appears later in the Newsletter.

For the Property Committee, Tom noted that the trees planted by Dean in the fall had received abundant rain. He also said the new roof on the Armand Building looks great.

Among other park issues to consider, Phil noted, is the spouting on the corner of the pavilion near the podium. He also recommended that we have a company come to power wash the pavilion floor before the next reunion and have the Kinsley

Company come in and remove leaf and branch debris. Bonnie mentioned that the railing by the registration table needs to be fixed.

For the Reunion Committee, Tom noted that we were blessed to have the catering done by the Miller family. Director Ben Miller will talk with his mother, Connie, who has been a contributor to many of our Reunions, about possibly catering again this year.

Harry suggested it would be good to get some young family members involved in setting up the tables and chairs for the Reunion, since most of the directors are advanced in age.

For the Education Committee, Ben shared that he received five applicants this year and sent information as requested. One of the four recipients asked for a renewal.

In continuing business, our Articles of Incorporation were approved by the state and the bylaws are in effect.

#### 2024 Reunion

This year's Reunion is scheduled for Saturday, July 27 at Heimwald Park.

As previously mentioned, we'll take the opportunity to remember our longtime historian, Dr. Charles H. Glatfelter, who would have turned 100 on May 11. He passed away February 6, 2013.

Dr. Charles was honored by the Association in 1994, which included the placing of a plaque on the eastern side of our pavilion. He served for 61 years as a Board member and was our historian for 57 of those years. He was the main figure in collecting our numerous archives and wrote two booklets for the family: The Early Glattfelder Family In America: An Overview and The Casper Glattfelder Association of America, The First Hundred Years, 1906-2005.

We are again planning a visual presentation, with numerous guests and board members expected to offer their thoughts and stories of Dr. Charles. Excerpts of three of his Reunion talks appear later in the Newsletter.

Also being planned is a trip to Gettysburg, where Dr. Charles lived for more than 60 years. It is scheduled for Sunday, July 28 and will start at the Adams County Historical Society, where Dr. Charles was executive director for 42 years. Other tentative stops will be the Seminary Ridge Museum, which was previously the home of the

ACHS and includes the Dr. Charles H. Glatfelter Welcome Center, and Glatfelter Hall on the Gettysburg College campus, where Dr. Charles was a member of the faculty for 40 years.

Depending on the response, the tour will either be by bus or vans from Heimwald Park or participants may need to provide their own transportation. Anyone interested in the Sunday trip to Gettysburg should contact Phil at 717-968-457 or email him at glatfelterph@aol.com.

#### President's Message

#### Diversity, Equity and Inclusion

The revision of our Charter of Incorporation and Bylaws at the 2023 Reunion marked a historic moment in our life together as an Association. For the first time, our distant cousins, descendants of Casper's brother John Peter, were acknowledged as bona fide members of our Association, as were the spouses of the descendants of both ancestors.

Occurring during the 160th anniversary year of the battle of Gettysburg, this action was all the more appropriate, for during our program 10 years before, we learned of the terrible toll paid by the southern (mostly John Peter descendant) branch of our family during that horrific war."

"Diversity, Equity and Inclusion" are the topic of many an essay, many a talk show and many a workplace nowadays. The revision of our governing documents prompted me to revisit a small paper prepared by longtime Association Historian Dr. Charles Glatfelter — whose centennial of birth is celebrated this year — regarding the diversity of the Directors.

At the time of our 1910 Incorporation, the number of Directors was fixed at 17. In the revision approved at the 2023 Reunion, the number of Directors is now a sliding scale of no fewer than nine but no greater the 17.

In 1910 — given the tremendous influence of John descendant Dr. Noah Glatfelter's book — nine of the 17 Directors were from his branch of the family. Four were descendants of Felix, two were descendants of Henry and two were descendants of Casper the younger. All of these were "purely" descended from one and only one son of Casper; there were none who could claim dual pedigree.

Nearly one decade ago, in 2005, a high water mark of diversity had been attained. There were two descendants of Solomon on the board, two descendants of Casper the younger and three of John. Six directors were exclusively descended from Felix, along with four others who had a second line of descent from Henry.

But now, through reasons inexplicable to me, the 1910 tables have all but been reversed. The present board is comprised of 10 who are exclusively descended from Felix, three who are descended exclusively from John and four who are descended from both Henry and Felix. Casper the younger and Solomon no longer have descendants among the Directors.

And, of course, neither do the descendants of John Peter.

In political philosophy, I am, in many ways, a libertarian and thus adamantly opposed to quotas, much less to "affirmative action" to redress past imbalances, whether objectively measurable or imagined.

Nevertheless, during the years ahead as vacancies occur among the Directors, it is my hope that the descendants of Casper the younger and Solomon may regain representation — and that the descendants of John Peter may at long last "take their place at the table."

#### Listening to Dr. Charles

A highlight for many Reunion-goers over the years was listening to our longtime historian, Dr. Charles H. Glatfelter. Following are excerpts from copies (some verbatim, some in outline form) of three of his talks:

July 31, 1988, the 83<sup>rd</sup> Reunion: "(The) Directors decided it would be appropriate this year to rededicate the grounds and pavilion, 75 years after grounds and the old pavilion was first used, 75 years during which they were kept up. All that's left of the old pavilion are some heavy beams which you can spot: they are old.

"(The Directors) decided also to use the same ritual used in 1913. If it looks very much like a religious service, that is because that is what it was. In tribute to the vision and labors of the Directors of 1913, we should not feel reluctant to trace their steps by using the ritual. If the religious language of 1913 offends us, that is more a reflection upon us than upon our forebears.

"Assuming that Rev. Adam Stump, who conducted the 1913 service, used the Lutheran Book of Worship to which he was accustomed, we are doing likewise today. ...

"These 17 (Directors) and their immediate successors (by 1913 there were six new Directors) conceived a grand plan, built well, donated time, teams, materials (treasurer's records show the number of hours worked and for how many there was no charge) and begged for money (many \$1, \$5, \$10, W.L.G. \$100).

"I believe they would be proud if they could return today to see the reunion a live institution, this pavilion in such excellent shape and grounds so presentable.

"So far, (there have been) 92 Directors. Many served only a few years and then faded away: age, illness, lack of interest. In a sense, we have the fourth generation of directors. In between, there have been many, almost all men, whose efforts in a major way kept the Association alive, through some very difficult times.

"Among those, excluding those live, I would like to pay a special tribute:

Monroe J. 1911-41, vice president 1919-35; Clarence L. 1912-63, caretaker 1918-62; Edward A. 1917-72, vice president 1945-66; John K. 1918-67, secretary 1926-35; Oscar J. 1919-51, treasurer 1927-35; Paul S. 1919-74, treasurer

1935-40; C. Harry 1927-30, 1934-49; Clark W. 1927-56, president 1931-34; Auburn H. 1929-70, president 1934-35; William H. 1930-45, treasurer 1940-45; Ernest S. 1932-66, president 1945-66; Edward I. 1935-50; Harry J. 1959-68; Spurgeon 1959-79, registrar.

"Of the 14, nine died in office. They had 453 years of service. Edward A. and Paul S. served 55 years each."

Also of note, in the memorial service at the 1988 Reunion, two died in vehicle accidents – Forrest Meyers and Fred E. Glatfelter – and one was a Peace Corps worker in West Africa, Dr. Scott Glotfelty. See more on Scott later in the Newsletter.

July 31, 1994, the 89<sup>th</sup> Reunion: After noting the annual memorial service and numerous important Glattfelders on those lists – such as Charles A. Bricker (related through his father and mother), Paul L. Folkemer (whose father founded a photography business in Baltimore), Elizabeth M. Gitt (last surviving granddaughter of paper mill founder Philip H. Glatfelter) – the speech turned to the main focus of that year's Reunion, honoring Dr. Charles.

"Many thoughts have been going through my mind during the last weeks. I realized what was going to happen. I was told last year this might happen, but I thought if I remained quiet enough, it would be forgotten.

"I participated in my first memorial service such as this in 1946, 48 years ago. I became a Director in 1944, one of the three chosen that day, the first new ones in nine years.

"I feel a kinship with the founders of this Association. My interest in the family began even before my election to the Board. I attended my first Reunion in 1932 and I know of one missed since.

"Why I became interested in family history, I do not know, but I did. I owe a lot to my grandfather, who for 18 years was a Director. He encouraged me in many ways (he had a third-grade education and was most responsible for my having a college one). He was deeply committed to this organization. ...

"When I became President in 1966, I wondered whether the Association and Reunion were dying or indeed already dead. I suggested, if dead, we should bury it. The reaction was, an endowment fund.

"In the years since 1966, the Association has been revived, thanks to efforts of many people in coming and contributing, thanks to efforts of many Directors and thanks to some national trends over which we had little or no control. ...

"The CGA as it exists today is an organization well worth supporting in every way you can. It has a glorious past, is obviously not dead or dying and if we make the effort, it will have an equally or more glorious future."

July 30, 2006, the 101st Reunion: "According to the Reunion letter, which all of you received, my task today is to reflect on 62 years of involvement with the CGA. It would be accurate to increase the total of years from 62 to 74, since the Reunion registration book records my name for the first time as being present on August 13, 1932. I do remember several Reunions during that decade, especially the one in 1939 when we had Swiss guests.

"My reflections on many years are already expressed on almost every page of the history published last year. We could really shorten this program if I were to stop now and urge you to go read the book. It costs little, is attractively designed and I get no royalty from it.

"I have just resisted the temptation to stop now.

"A year after I was elected to the Board in 1944, the treasurer died. For reasons I do not remember, I was elected to succeed him. Although I heard no one say it, I am sure some of the old directors wondered what in the world was happening to the Association when it entrusted all of its money to a 21-year-old fellow. ...

"I learned a long time ago, from some of the founders themselves, that in order to survive and prosper, this organization needs a lot of tender, loving care.

"If we search for reasons why it has survived and prospered through the years, we should look first to the very beginnings. The constitution the founders adopted in 1906 stated their purposes: to perpetuate our history, to remember our fathers and to cultivate sociability among us. ...

"We should then look to a board of 17 Directors which, especially in the last quarter century, has acted to make the home woods entrusted to their care in 1913 much more attractive than ever before. That Board has added

significantly to what the Association does in carrying out its mission, from the Newsletter to the website.

"A few years later, the founders obtained a notfor-profit charter of incorporation and then gave us a permanent home, a home in the woods, a heimwald. These gifts have been both blessings and burdens for us, but let no one forget. The charter and the woods have imposed upon us a responsibility and a discipline few families in this country share."

#### Finding his ancestors

Among the messages sent to our website, a Roger Henry asked for help locating some of his relatives.

"I would like to reach out to descendants of Wesley Glatfelter (Johan Jacob K.'s grandson) in hopes of identifying, and sharing with, photos I have that may include Wesley and others. I have one that is of a group photo taken in Nortonville, Kansas, at the home of Henrietta and Wesley Glatfelter. Doing my best to identify persons in the collection of photos I have. Does the Glattfelder Association of America have a procedure for reaching out to distant, very distant, cousins?"

Well, Roger, here is one way we can do that. Contact us on the website if you're related to Roger.

He adds that Wesley Glatfelter is his great-great-great-grandfather.

#### Well-represented family

Director Harry Gladfelter recently passed along some correspondence he had received from one of the gentlemen from his research on "The Glattfelders and Their Patents" programs from 2021 and 2022. It is related to a possible future program on Glattfelders in medicine.

The email was from Mel Glotfelty. In it, Mel explained how he recognized a name Harry had been researching, a Dr. Philip R. Glotfelty III. Mel, looking at Philip's obituary, said in the email, "Well, right then, I knew who he was and was SO EXCITED! His grandfather, The Rev. Philip R. Glotfelty Sr., was ... also my grandfather's older brother. So, his dad was my dad's first cousin and he is my second cousin. I

have been able to add them to my family tree. ... Thank you so much for sharing that info."

The name immediately struck a chord with the Association and after some research, we found that Glotfelty family well-represented on the brick patio at Heimwald Park, under Solomon.

In the extensive records kept by historian Dr. Charles H. Glatfelter, we found that Philip placed several brick orders with us. That prompted one letter from Dr. Charles in 1993 inquiring about clarification of Philip's line. Philip replied with this: Casper, Solomon, Henry Glotfelty (1779-1887), Philip John Glotfelty (1806-1868), Henry Glotfelty (1836-1908), Philip R. Glotfelty (1877-1957), Philip R. Glotfelty Jr. (1905-), Philip Glotfelty III (1933-), Philip R. Glotfelty IV (1958-) and Philip R. Glotfelty V (1983-).

As with numerous of our relatives, Philip had a desire to be well-represented on our patio. In 1997, he wrote to Dr. Charles: "This should complete the bricks for the Glotfelty family from Solomon 1738 to Parker Solomon 1996. I have included the husbands, wives and children of all my family, as well as the wives of Philip Sr. and Philip Jr."

The total order comes to about 30 bricks. That includes the two most recent, in 2009, when Philip bought one for Philip R. Glotfelty VI, and 2010, when he sent an order for a correction (which was actually already correct) and, in one of the few cases, a removal for somebody no longer in the family.

The fact that Philip made that large of a contribution to our brick patio is by itself noteworthy to the Glattfelders. Reading his lengthy obituary adds even more to that.

"Philip was born September 2, 1933, in Carbondale, Illinois. Some of the activities in his youth included exploring woods, attending church events, bird watching, sailing and participating in Boy Scouts. In 1949, he was presented with the Eagle Scout Award. His sons, Philip and Steve, and grandsons, Philip and Parker, achieved the same distinction.

"In 1975, he took his family to the Boy Scout World Jamboree in Norway.

"As a preacher's son, Phil lived in several towns throughout his youth. He graduated from Albion College with a bachelor of science degree in pre-med.

"He gave his life to Christ at an early age and graduated from Wayne State University with his doctor of medicine degree in 1959.

"He married Marlene J. Woelfle in 1956, with Phil's father officiating. Phil started his family and general surgical practice in Marshall, Michigan, in 1965. He served as a physician until 2000."

There was much more to Phil's obituary, but one last message can be added:

"On the Friday before his passing, Phil's daughter declared, 'Dad, you may have forgotten a lot of things due to Alzheimer's, but you remembered all the important things.'

"Without skipping a beat, Phil replied, 'I never forgot when someone did something nice for me."

Dr. Philip Rutherford Glotfelty III passed away October 28, 2021.

#### Heart-wrenching story

This is another item passed along by Director Harry Gladfelter as he was doing research for Glattfelders in medicine:

"Dr. Scott A. Glotfelty, DVM, was a valued member of our CVM, Virginia Tech, community and the Class of 1986. His contributions to the college and the profession of veterinary medicine have made a lasting impact. He will continue to be remembered fondly and missed dearly.

"Dr. Scott A. Glotfelty, 27, a Peace Corps volunteer in Togo, W. Africa, died March 23, 1988, of multiple bee stings, at Dapaong Hospital.

"He was born Dec. 13, 1960, a son of Ruth Dipaolo, of Accident, Md., and the late Robert Glotfelty. He is survived by two brothers, Rodney and Barry and two sisters, Joan Sussman and Carol Bass, all of Accident, Md.

"He received a bachelor of science degree from the University of Maryland and a doctor of veterinary medicine from the VA-MD Regional College of Veterinary Medicine. Prior to joining the Peace Corps, he had worked at the Pineview Veterinary Hospital, Oakland, Md., where he served as a relief and emergency veterinarian. In the Peace Corps, he was serving on a small husbandry and extension program. ...

"The family is establishing a Scott Glotfelty Trust Fund for humanitarian purposes to further the pioneer work Scott had started for small animals in Togo. Contributions may be made through the funeral home."

#### A century ago

Among the CGAA archives is a newspaper article from 100 years ago.

It is dated January 10, 1924, and titled "Glatfelter's Park; How It Was Started," subtitled "Money Spent For Ground and Costs of Up-Keep Announced; Has \$375 Indebtedness." It reads, in part:

"Additional information of the financial operations of the Casper Glatfelder Association of America, during the past years has just been announced by officers of the association. Money contributed by the members was used for the purchase of ground for a park at Glatfelters and the erection of a pavilion.

"In 1910, ground was purchased from Martin Glatfelter for \$200. An itemized statement of the expenses during the year follows: charter, \$5.25; pavilion and labor on ground, \$820; advertising, \$14.20; labor, \$67.90; cementing pavilion, \$567.84; seats, \$456.32; drayage, \$13.50; labor, \$236.38; taxes paid to date, \$75.80; interest, \$133.50; lumber, \$39.02; total \$2528.21

"The park at Glatfelter's station along the Penn R.R., only nine miles from York, affords ample accommodations for outings and picnics. Clarence L. Glatfelter of Glatfelters is caretaker of the grounds. There is a pavilion 40 by 50 feet, with comfortable seats that can be moved and arranged to suit any occasion, a refreshment building, good spring water and scenery that is unsurpassed.

"This ancestral home of the Glatfelters is raised up to perpetuate the memory the great grandfather who braved the waters and the great deep, leaving his home in Switzerland, coming to York County and choosing a spot that closely resembled the home he left. Members of the clan from this county who have had the pleasure of visiting Glattfelden in famed Switzerland tell of the beauty of the hills surrounding the plot where dwell the members of the clan."

Another item from the archives is from 1955. It is an announcement for that year's Reunion, which was the 50<sup>th</sup>, scheduled for August 13. In part, it reads:

"The Southern York County Band will furnish music both afternoon and evening. Soup, coffee, sandwiches and refreshments will be on sale as usual. There will be motion pictures in the evening and some slides of scenes taken in Switzerland by Donald Dusman, Boring, Maryland, while on leave from his army duties.

"We have completed all of our projects, such as placing a new roof on the pavilion, erected a monument at Bupps Union cemetery and the spring house and water drinking fountain with the plaque and its beautiful inscription. All of the buildings have been painted and everything is now in good condition. This is your home and the Directors want to do everything so that you might be proud of it. If you have any suggestions for any improvements, we should be only too glad to carry out your suggestions.

"We cordially invite you to attend our reunion this year. This is our Golden Anniversary. We want to honor those who organized our family in 1906 and pay tribute to those who made this anniversary possible."

Both items illustrate the ongoing mission of the Casper Glattfelder Association of America. So while "we cordially invite you to attend our reunion" this year as well, we also ask you to consider helping the association with its financial responsibilities.

#### **Scholarships**
